#### DIGITAL CAMERA POLICY

The Georgia Historical Society allows limited use of digital cameras in the reading room as a means for providing reproductions of research materials that are deemed too fragile by GHS staff to undergo photocopying or scanning or are too large to be photocopied or scanned in-house (greater than 11 x 17). Use of digital cameras for this purpose must be approved by the Library and Archives staff **prior** to the use of the camera. *Materials that can be photocopied or scanned using GHS staff and equipment may not be digitally photographed by researchers.* Limited use of digital cameras is permitted to ensure the preservation of library and archives materials only. ***All forms and fees (if applicable) that apply to ordering digital reproductions through GHS apply to digital reproductions created by researchers with a digital camera.*** Use of traditional 35 mm cameras is not permitted.

#### FEES AND REGULATIONS FOR USE:

- Items to be photographed must be approved by Library and Archives staff prior to use of the camera.
- A Library and Archives staff member will supervise the digital photography done by the researcher.
- Depending on staff availability, an appointment may be necessary to use digital photography.
- Library and Archives staff reserve the right to view digital images on the researcher's camera to verify the number of images taken.
- Researchers using digital cameras for images intended for personal use must read and sign the Georgia Historical Society *Condition Agreement for Personal Use* and an *Image Reproduction Order Form*.
- Researchers using digital cameras for images intended for publication, exhibit, display, or any other commercial or non-profit use must read and sign the Georgia Historical Society *Condition Agreement for Commercial and Non-profit Use*, the *Image Reproduction Order Form*, the *Permission Application-Permission to Publish*, and pay the associated use fees as outlined in the Georgia Historical Society *Visual Materials Use Fees for Commercial and Non-profit Use*.
- Digital copies of the images taken must be provided to the Georgia Historical Society within 30 days from the date the images are created. *See reverse.*
- When not in use, cameras must be kept in a locker at the reference desk.

\$4 per digital image for members

NO MORE THAN 5 IMAGES MAY BE TAKEN OF ANY SINGLE COLLECTION.

For example: 5 pages from a book, pamphlet, folio, or vertical file

5 pages from a manuscript collection

5 images from a visual materials collection

5 maps or architectural drawings (sections of a single oversized item count towards the five image total)

5 artifacts
